#### RELEASE AND WAIVER OF CLAIMS

For valuable consideration, the receipt and sufficiency of which are hereby acknowledged Renter does hereby remiss, release, and forever discharge the Company, the Company's agents, servants, successors, heirs, executors, administra- tors and personal representatives, of and from all, and all manner of, actions, causes of action, suits, proceedings, debts, dues, contracts, judgments, damages, claims, and demands whatsoever in law or equity, which the Renter ever had, now has, or which the Renter's heirs, executors, administrators or personal representatives hereafter can, shall, or may have for or by reason of any matter, cause, or thing whatsoever arising out of this Agreement; out of the use (misuse, or abuse) of the Boat; or in any way arising out of the rental relationship between the Renter and the Company.

#### INDEMNIFICATION

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the renter hereby expressly agrees to indemnify and hold harmless the Company, the Company's agents, servants, successors, heirs, executors, administrators and personal representatives against all suits, actions, claims, demands, or damages that arise out of the Renter's use, misuse or abuse of the Boat.

A fee of up to \$500.00 may apply for excessive cleaning. A refueling charge of 50% plus the cost of fuel will apply if the fuel tank is not full upon arrival.

#### TERMS AND CONDITIONS

- 1. Assumption of Risk. The renter acknowledges that the activities for which the Boat is designed include inherent dangers, Including the risk of bodily injury and/or death. The renter assumes and accepts all risks associated with the use of the Boat.
- 2. Acceptable Use. The renter agrees and acknowledges that he/she will be the sole operator of the boat, and will use the Boat in a careful, safe and conscientious manner. The renter shall at all times observe and adhere to any rules and guidelines posted by the Company, and any applicable laws or regulations. Renter shall be responsible at all times for the safety of any and all passengers in the Boat.
- 3. Prohibited Activities. The renter shall not violate any of the following rules and regulations during his/her operation of the Boat:
  - There is no smoking while in the Boat.
  - There are no alcoholic beverages permitted in the Boat. Company reserves the right to inspect any coolers, bags or other containers belonging to the Renter or any of the Renter's Passengers.
  - There are no pets permitted in the Boat, unless prior arrangements with managements have been made.
- 4. Children. Any children under the age of 12 in the boat must wear a life jacket at all times.
- 5. Unsafe Use. If at any time the Company determines that the Renter has engaged in an unsafe or hazardous use of the Boat, the Company may board the Boat, or otherwise notify the Renter that it is immediately terminating the rental. Upon termination, the Renter must return the Boat to the designated docking area immediately. If the rental is terminated for unsafe or hazardous use, Renter will not be refunded his/her security deposit. The Company shall determine, in its sole discretion, whether any behaviour or activity is "unsafe or hazardous."
- 6. Condition of Boat upon Return. The Renter shall return the Boat to the designated docking area clean, free of garbage and debris, and in the same condition as it was in when given to Renter, excepting ordinary wear and tear. Renter shall be responsible for any damage caused to the Boat during the rental period. The Company shall retain any portion (or all) of the renter's security deposit as necessary to cover repairs for such damages. To the extent that damages to the Boat exceed the amount of the security deposit, the Renter shall be billed by the Company for the full amount of damages caused by the renter during the rental period, including reasonable lawyer's fees.

## RENTER'S

### **BOAT RENTAL AGREEMENT**

- 1. DRIVER'S LICENSE IS REQUIRED no one under 19 years of age and no one who is visibly intoxicated or under the influence of illicit drugs may rent any boat.
- 2. ALL BOATS MUST STAY WITHIN LAKE OKANAGAN (or other designated lake as agreed to prior to rental). Any boat that needs to be picked up or rescued out of area may be charged up to \$200.00 per hour.
- 3. DAILY RESERVATION USUALLY BEGINS AT 10:00 A.M. unless prior arrangements made.
- 4. ALL BOATS ARE DUE BACK ONE HOUR BEFORE SUNSET unless rented for more than one day or prior arrangements are made with SUNWAVE BOAT RENTALS. You are solely responsible for all damage and loss due to wind, storm, theft, etc. If the boat is not at the marina overnight you may be required to move/retie the boat, when necessary, to protect it from winds, waves and other elements.
- 5. All reservations are made with the understanding that RESERVATIONS ARE CANCELED WITHOUT NOTICE ONE HOUR AFTER YOUR PREARRANGED ARRIVAL TIME unless we have been notified by telephone of your late arrival.
- 6. CANCELLATIONS reservation deposits will only be refunded if you give notice at least 10 days before your expected arrival date. Refunds will be issued due to poor weather conditions (rain or high winds) on the day of rental prior to renting a boat.
- 7. SECURITY DEPOSITS REQUIRED \$1000 to \$3000 depending on boat rented.
- 8. SECURITY DEPOSIT & RENTAL FEE MUST BE PAID IN FULL IN ADVANCE.
- 9. SECURITY DEPOSIT RETURN Upon return of boat, an inspection will be made, gas tank will be filled and deposit will be returned within 72 hours, minus any repair cost of any damage done to the boat, motor or new replacement value of any lost equipment.
- 10. PROPELLER RECONDITIONING FEE \$250 to \$3000 The propeller will be inspected upon return of the boat. Severe prop damage will result in new replacement and loss of entire deposit plus possible future charges to cover hidden related damages.
- 11. ALL FUEL IS EXTRA Tanks will be full when you leave and the boat must be returned with the tanks full. A refueling fee of \$100 will be charged if Sunwave staff refuels the boat ( plus the cost of the fuel ).
- 12. BREAKDOWNS must be reported within the hour or normal contract charges will continue.
- 13. NO BOATS TO BE USED AFTER DARK NO EXCEPTIONS.
